Decisions on the Disability Income Plan

<u>Issue:</u> Based on assumptions adopted in 2010, the most recent valuation report shows that the new Annual Required Contribution (ARC) is 0.38 percent for fiscal year ending 2017. However, subsequent to the valuation report, an experience study has been performed. Based on the proposed assumptions from the experience study, the Annual Required Contribution (ARC) for fiscal year ending 2018 is estimated to decrease to 0.15 percent.
