## ANNUAL REPORT ON SUPPLEMENTAL INSURANCE

### **Background**

Active state and local government employees during their working careers are able to participate through their employer in group vision, dental, life and other insurance options, in addition to health care coverage. As a retiree, those benefits are not portable, so retirees often have limited or no coverage options available at affordable rates. The NC Retirement Systems Division (RSD) makes coverage available on a participating basis to retirees and benefit recipients at competitive prices. Current products include dental and vision through UnitedHealthcare and identity theft through LifeLock. Our contract with UnitedHealthcare expires December 31, 2020, and our contract with LifeLock expires December 31, 2019.

RSD partners with the Pierce Insurance Agency who serves as the exclusive broker and administrator for the program.

Pierce Insurance Agency is a family-owned company established in 1955 in Farmville, NC, and was awarded the contract to manage supplemental insurance benefits to retirees of the North Carolina Retirement Systems through a formal bid process. Renewal options have been exercised since the execution of the initial agreement. The existing contract was recently extended through December 31, 2020.

#### **Status**

Pierce Insurance Agency has administered and marketed the program effectively and efficiently. We have experienced consistent annual growth in participation since contract inception with Pierce Insurance Agency. The total participation increase over that span exceeds 85 percent with more than 180,000 retirees currently participating.
