June 1, 2022 – May 31, 2023**

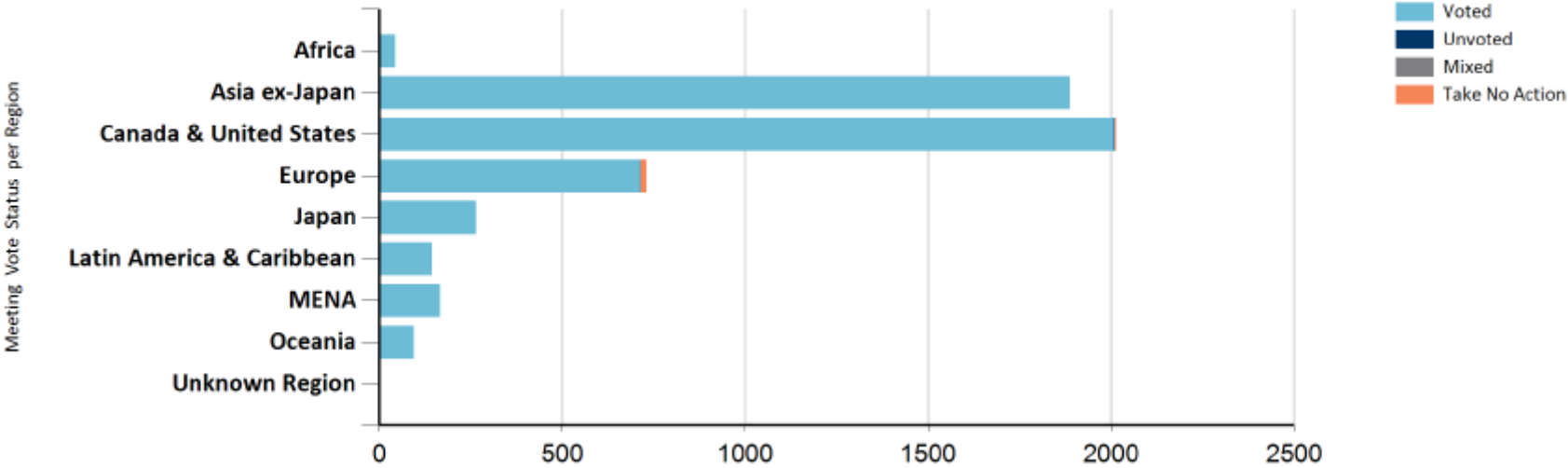
## Proxy Voting Activity Summary

- Glass Lewis provides proxy advisory and voting services to both the Investment Management Division (IMD) and the Supplemental Retirement Plans (SRP). Glass Lewis charges a fixed fee, which is divided proportionally between IMD and SRP based on the number of ballots voted.
- Ballots for IMD and SRP are voted according to Glass Lewis's standard proxy voting guidelines, which the Board adopted for SRP in 2017.
- With the new Glass Lewis contract in September 2022, IMD and SRP began participating in BlackRock's Voting Choice program, which allows IMD and SRP to vote the proxies associated with their shares of BlackRock's collective investment trusts (CITs). The addition of CITs greatly increased the number of ballots voted.
- In the 12 months beginning June 1, 2022, SRP voted on a total of 52,706 proposals. In comparison, during the same 12-month period beginning June 1, 2021, SRP voted on 6,669 proposals.

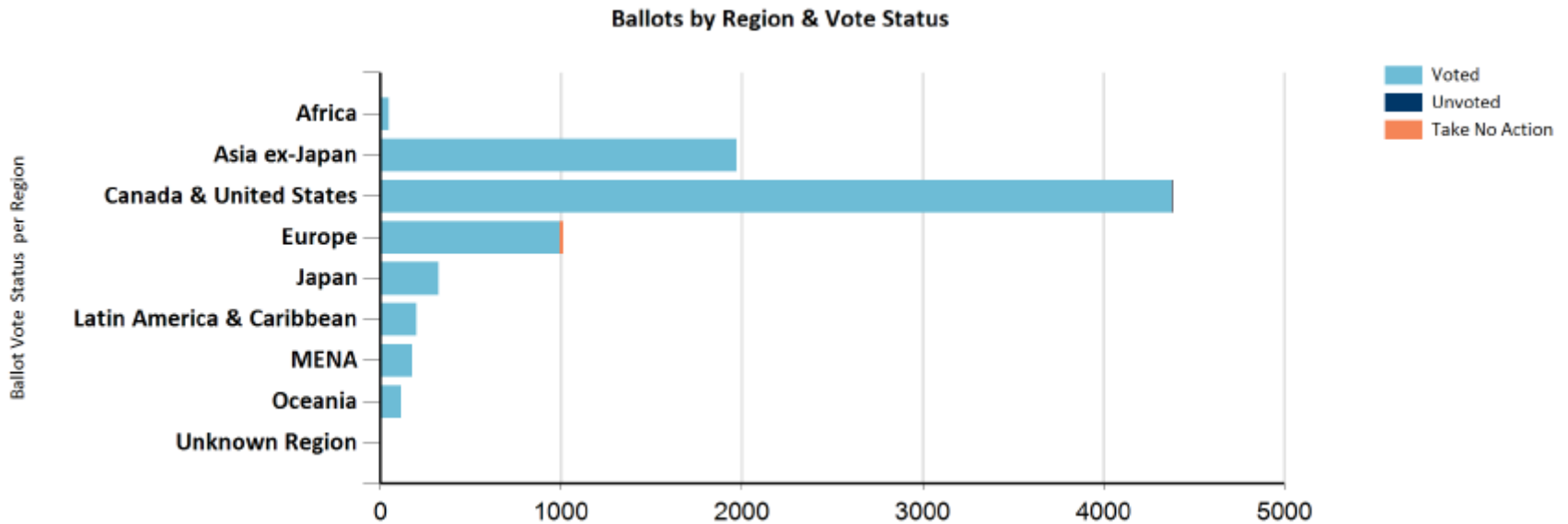

Meetings by Region & Vote Status



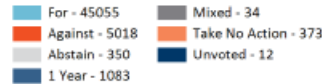
